3.	Approval of minutes and matters arising	Item 7 of the previous minutes should read Public Social Partnership and not Public Service Partnership. It was also agreed that abbreviations in the minute will be written in full.	
		Matters Arising Item 6 – The Moray ADP Co-ordinator raised the Children and Young People Act at the team meeting. The team are happy with the Act as it cross references with work already being done.	
		Item 8 – There has been a delay in pulling this together due to awaiting he return of information. Short focus groups will be set up and the group will ensure that it cross references with the Early Years and Young People action plan.	
4.	Early Years and Young People Sub-group: Work Plan Briefing	A briefing paper on drug and alcohol parenting was compiled by the ADP Co-ordinator for the group to discuss a structured work plan that would cross reference with the recovery agenda. The Substance Misuse, Pregnancy and Early Years report was circulated to the group and agreed that the recommendations from the report can still be used in the plan. It was agreed that the first two recommendations of the briefing are brought to the Partnership table for consideration. The Early Years and Young People Sub-Group will work on recommendation 3 of the briefing note. It was agreed that 2 years of the plan may not be long enough due to the 10 year plan set by The Moray Council. However, the 10 year plan has no direct link to children and young people and substance misuse.	
		The Early Engagement Team Manager will bring to the Integrated Children Working Group the discussion of what is currently being delivered by staff working with children, young people and families with substance misuse issues and how this can link with existing training programmes. It was agreed that a skeleton outline of a performance management plan for the group will be brought to the table for discussion. The report

5. Public Social Partnership	The final bid awarded for the Public Social Partnership was £150k. The facilitator post has been filled. Interviews for the Support Workers post was undertaken and the successful candidate is currently considering the offer. The project looks at a change of service delivery and is based in the rural areas surrounding Elgin. It is hoped that the project will help families engage better with services and the community. The project workers will link in with the Early Years and Young people Sub-group as well as other collaborative partners.

6. Children Act (Scotland) 2014	The Children Act (Scotland) 2014 PowerPoint was circulated to the group. Anne Pendery (Strategy Development Officer) is currently working on the implementation of the Act within Moray. Part 1 of the Act has been implemented and approximately 10 children in Moray aged 2 years old have came forward who are eligible for childcare provision. It was expected that there are approximately 80 children in Moray who are eligible.
