1 Introduction

This report follows the objectives of the Moray ADP Delivery Plan 2015-2018. It will focus on local milestones due to be reported on a quarterly basis however additional information has been included for some annual milestones where required. Section 9 covers the current caseload of Alcohol & Drug Services in Moray and should allow for any significant trends or emerging issues to be identified.

Data used within this report has been collated from a variety of sources including; the three main support services in Moray (via the Drug & Alcohol Assessment Form), Recovery Outcome Tool reviews, Scottish Drug Misuse Database (SDMD), NHS, Police Scotland and Scottish Fire & Rescue Services.

The Moray ADP Delivery Plan and associated actions are currently under review with a new plan expected to be in place for the period 2018-2021 by April 2018.



9 Quarter 2 2017/18; New Service User




- During quarter 2 2017/18, 92 people are recorded as having a first assessment with Moray Alcohol & Drug Services, a 7% increase from quarter 1.
- 59 service users (64%) were male with 33 (36%) female, the same proportion as recorded in quarter 1.
- 3 service users were aged 17 & under. All were aged 16 on attending their first assessment.






- As in quarter 1, the majority of those undertaking a first assessment in quarter 2 (71%), self-referred to the service.
- Referrals from a Health Service (GP, Mental Health and Primary Care) were the next most common route into Alcohol & Drug Services with 16% of service users referred this way.



- For the second quarter this year, Alcohol has been the most common substance being misused by service users.
- In a change from quarter 1, service users who stated they were misusing both Alcohol & Drugs has increased; from 15% in quarter 1 to 22% in quarter 2 while those stating they had been misusing Drugs only fell from 28% to 25%.
- Of the 69 clients stating they misused alcohol, the majority (77%) stated they drank spirits or wine. 39 (57%) stated they drank on a daily basis. 5 stated they were binge drinkers with 2 reporting a binge could last 10+ days.
- Of the 43 clients misusing drugs, 20 (47%) were noted as cannabis users while 10 (23%) stated heroin or methodone was their main drug. 13 of those using cannabis stated they did so on a daily basis. All 10 service users misusing heroin or methodone stated they did so daily. 1 service users who stated they had problems with both alcohol and drugs claimed to be spending in excess of £250
- Similar to quarter 1 data, the majority of new service users in quarter 2 stated they owned or rented their home (90%). 47% of these service users live alone.
- A significant amount of new service users (70%) stated they had no worries in relation to their accommodation.



- 73 of the 92 new service users in quarter 2 provided details of what they believed had triggered their substance misuse problems.
- Compared to quarter 1, experience being parented and trauma have replaced illness and relationships as some of the most common triggers.
- Bereavement has remained as one of the top 3 triggers for substance misuse.

10 Quarter 2 2017/18; Recovery Outcome Tool Reviews

Over the past four years, the Scottish Government has been working with a range of partners across Scotland to develop a Recovery Outcomes (RO) focused tool that would help evidence recovery journeys. The RO tool was developed as a key component of the Drug & Alcohol Information System (DAISy) with the aim of providing a consistent and comparable picture of recovery for drug and alcohol service users across Scotland. This tool will be mandatory for all ADPs from April 2018 when the DAISy system goes live.

On 01 July 2017, the Moray Alcohol & Drug Partnership moved from Outcome Star to the Recovery Outcome Tool. The Recovery Outcome Tool continues to track the progress of Service Users over 10 key areas although these vary slightly from those previously covered by Outcome Star.

Between 01 July and 30 September 2017, only 1 progress review was undertaken using the new system. This service user was required to make a change in four areas, Mental Health & Emotional Wellbeing, Relationships, Self-Care & Nutrition and Substance Misuse. Figure 10 below highlights the results made by this user in each area and shows of the four areas, no change was reported for three while a decline was noted in the area of Substance Misuse.
